

## St John's College, Cambridge, Data Protection Statement: Users of the College Website

This data protection statement explains how St John's College, Cambridge ('we' and 'our') handles and uses information we collect when you visit the College website – [www.joh.cam.ac.uk](http://www.joh.cam.ac.uk). Where you engage with the College for another purpose (e.g. as a prospective or current student, as a previous student, as a member of the College or as a visitor to the College), other data protection statements explain our management of your personal information – see <https://www.joh.cam.ac.uk/data-protection-information>. Where you enter your personal information into an online form for any specified purpose, you will be told about the use we will make of that information (e.g. to send you newsletters, consider your request for use of College facilities, or to enable your attendance at an event).

The legal basis for processing your personal data is that it is necessary for the purposes of our legitimate interests, where we have concluded that our interests do not impact inappropriately on your fundamental rights and freedoms. You may ask us to explain our rationale at any time.

We collect and process your personal information for operating and improving our webpages, analysing their use and ensuring the security of our website.

*We also use third party developers to collect standard internet log information and details of your visitor behaviour patterns. We do this to find out, for example, the number of visitors to each page of our website. Our Website is hosted securely and in conformity with current data protection legislation by a third party, Code Enigma, a company based in the UK (<https://www.codeenigma.com/>).*

Online forms will not normally be retained beyond the point necessary to fulfil a contractual obligation on the part of the College.

You have the right: to ask us for access to, rectification or erasure of your information; to restrict processing (pending correction or deletion); to object to communications or direct marketing; and to ask for the transfer of your information electronically to a third party (data portability). Some of these rights are not automatic, and we reserve the right to discuss with you why we might not comply with a request from you to exercise them.
